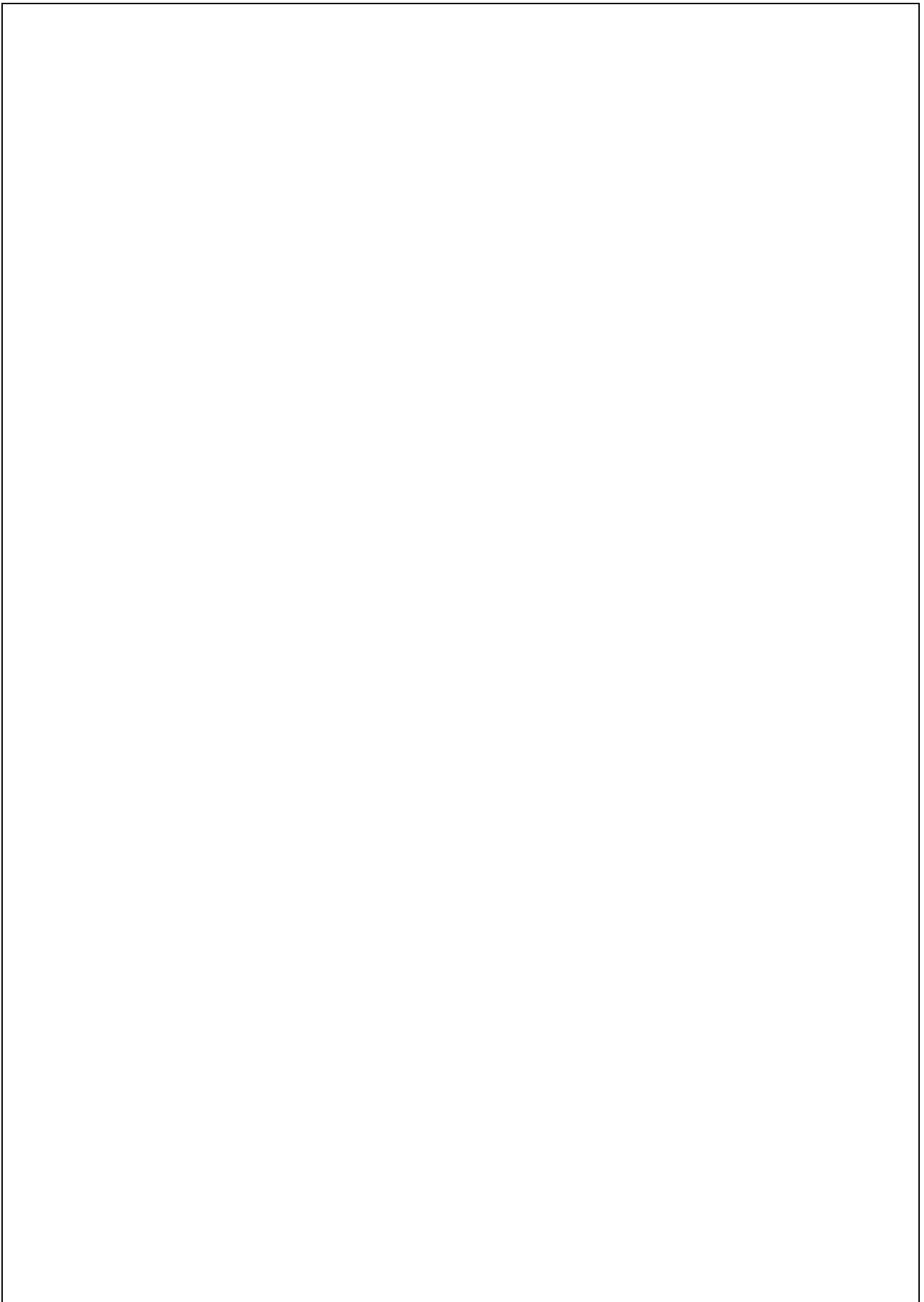
All applicants are required to complete the following application form.

1. All submissions will be treated confidentially.
2. NOA's development contributions are guided by principles of political neutrality, transparency, and avoidance of conflicts of interest. NOA does not make political donations or contribute to electoral campaigns.
3. Submission of this application form does not guarantee that financial support or assistance will be provided.
4. Only applicants that qualify for enterprise development will be considered i.e. only Exempt Micro Enterprises (EMEs) or Qualifying Small Enterprises (QSEs) that are at least 51% Black owned or 51% Black female owned.
5. Preference will be given to eligible initiatives located in the Makana Local Municipal area.
6. Applicant are required to share all relevant documentation to support their application.
7. All applications that are received will be required to undergo an evaluation process, which may include due diligence site visits.
8. Successful applicants will be required to sign documentation to enable sponsorship and support verification exercises (e.g. letters of gratitude, enterprise development agreements and any other documentation that may be required).
9. If applicants have not been contacted on the outcome of their application within 6 months following the submission deadline, these applications should be considered as unsuccessful.
